1.	Tamil Nadu	Bhavani	Details to be included in action plan regarding 36 outfalls whether all carrying sewage only or both sewage and sullage.	Out of the 36 outfalls, 33 outfalls are sullage and only 3 outfalls are sewage as per the reports received from TNPCB Laboratories. (Annexure I)
2.	Tamil Nadu		Justification with respect to non requirement of secured land fill site after biomining of legacy waste to be clearly included in the action plan.	Bio-Mining of Legacy waste results in components such as enriched bio — earth, RDF and inert material. The items are separately stored and disposed as and when segregated. The enriched bio — earth is distributed to farmers for soil reclamation purpose. RDF (Refuse Derived Fuel) consists of plastic, glass, metal, wood, clothes etc which is disposed to concerned recyclers for recycling or fuel purposes. Inert material which consists of sand and stoned is used for filling low lying areas. None of the material is left behind without disposal and hence there is no necessity for secured land-fill. (Annexure II). *Fecal colifom <100 MPN/100ml is to taken as
