In the Government order read above, for improvement of livelihood of Manali Ennore residents and restore ecological equilibrium and overall biodiversity, orders have been issued for setting up of the Special Purpose Vehicle (SPV) namely Manali Ennore Restoration & Rejuvenation Company (MERRC) which will focus on greening initiatives, de-silting, solid waste management, pollution control, mangrove restoration and community infrastructure development in the Manali Ennore area.

- 2. The company will be a not-for-profit body registered under Section 8 of the Companies Act, 2013. It will be funded through Corporate Social Responsibility and Government allocations. The company has been formed as a 100 % Tamil Nadu Pollution Control Board owned Private Limited company with Nominee Shareholders from Tamil Nadu Pollution Control Board. Manali Ennore Restoration and Rejuvenation Company (MERRC) has been formed with the following composition as the first Directors:-
