ORDER:

In the Government Order first read above, a Special Purpose Vehicle (SPV) viz., Manali Ennore Restoration & Rejuvenation Company (MERRC) has been set up and the which shall be a not-for-profit body registered under Section 8 of the Companies Act, 2013. The company will be funded through Corporate Social Responsibility and Fund allocation by the Government which will focus on greening initiatives, de-silting, solid waste management, pollution control, mangrove restoration and community infrastructure development.

- 2. The company will be formed as a 100 % Tamil Nadu Pollution Control Board owned Private Limited company with Nominee Shareholders from Tamil Nadu Pollution Control Board.
- 3. Due to Administrative Reasons, for smooth functioning of the organization, it was decided to rename the Manali Ennore Restoration & Rejuvenation Company (MERRC) as "Manali Ennore Restoration & Rejuvenation Council" (MERRC). Accordingly, the following amendment is issued with immediate effect.
