Manobalan and the seniority of Thiru.S.Manobalan is fixed at S.No.77 instead of 76 notified in the Proc. cited and otherwise no objection has been received from any Assistant / Typist and hence, the revised seniority of Assistant/Typist notified in proceedings cited is hereby confirmed.
