



Feedback of Industries on Issue of Consent To Operate(CTO)/ Renewal Consent(RCO) as a Block

Tamil Nadu Pollution Control Board



The TNPCB categorized the Industries under Red, Orange, Green and White, based on the Pollution Index Score as per the guidelines issued by the Central Pollution Control Board (CPCB). The industries under Red, Orange and Green shall get Consent to Operate (CTO) / Renewal of Consent (RCO)

B.P No.05 issued on dated 02.08.2016 mentioned about the provision of extending the validity period for Red/Orange/Green category industries for 5/10/14 years respectively on remittance of total consent fee for the entire period in advance. But this provision has not been properly reached industries. In spite of this provision, CTO / RCO are issued to Red category industries for one year and Orange & Green Category industries for two years only.

The Hon'ble Minister for Environment, Climate Change, Youth Welfare and Sports Development made an Announcement on the Floor of Legislative Assembly on 03.09.2021 for the financial year 2021-2022 "Issue of Consent to Operate(CTO)/Renewal of consent as a Block, instead of issuing consent for every year, under Ease of Doing policy of the Government creating awareness among Industries"

This will facilitate the industries get away from making applications every year and reduce the file processing time of TNPCB and enhance monitoring of various waste management and abatement of environmental pollution. The industries that are willing for extended period of consent can avail this option.

As a part of fulfilling the Ease of Doing Business Policy of the Government and towards the compliance of the Hon'ble Minister Announcement, TNPCB grant CTO / RCO to the Red, Orange and Green category industries for the extended period of 5/10/ 14 years respectively on getting the necessary consent fee from the financial year 2021-22.

TNPCB has issued CTO/RCO as a block to 8509 industries for the period from Dec 2021 to 31.10.2022. The industries have furnished their feedback on the usefulness of this Announcement and their benefits obtained by this provision is documented.

The Honble Minister for Environment and Climate Change, Youth Welfare and Sports Development made the following Announcement on the Floor of Legislative Assembly on 03.09.2021

ORDER:

Tamil Nadu Pollution Control Board accords Consent to Operate(CTO) as per the provisions under the Water (Prevention & Control of Pollution) Act, 1974 and Air (Prevention & Control of Pollution) Act, 1981, after collection of necessary consent fee. The Consent to Operate (CTO) is to be mandatorily obtained by industries categorised as Red, Orange or Green as per the Guidelines issued by the Central Pollution Control Board (CPCB) for the period as prescribed in their respective category Guidelines. As a part of the Ease of doing business Policy of the Government and to move towards greater transparency, Government has made the following Announcement on the floor of Tamil Nadu Legislative Assembly on 13.09.2021:-
