#### **Preface**

The Government of Tamil Nadu has been at the forefront of promoting circular economy principles and sustainable waste management across various sectors. In line with these efforts, the Tamil Nadu Pollution Control Board (TNPCB) has launched several initiatives, including the Meendum Manjappai (MM) Campaign, the Tamil Nadu Fishnet Initiative (TNFI), the Online Waste Exchange Bureau; and the Voluntary Green Rating of Industries.

TNPCB is also actively implementing the Extended Producer Responsibility (EPR) framework for the management of plastic packaging waste, e-waste, battery waste, used oil, and waste tyres, as mandated by the rules notified by the Ministry of Environment, Forest and Climate Change, Government of India.

In continuation of these initiatives, TNPCB has prepared this Recycling Directory as a step towards strengthening stakeholder engagement and facilitating access to reliable information on authorized recyclers. The directory is intended to serve as a practical reference for manufacturers, producers, importers, brand owners, bulk consumers, and other stakeholders involved in the generation and management of waste. The directory includes essential details such as names, addresses, and contact information of authorized recyclers to support easy access and coordination. It provides a structured compilation of authorized recyclers operating in Tamil Nadu, based on data sourced from the Central Pollution Control Board's EPR Portal and TNPCB's Online Consent Management and Monitoring System.

By promoting informed linkages between waste generators and authorized recyclers, this initiative aims to support efficient collection, channelization, and recycling processes, ultimately contributing to the State's vision of a cleaner, greener, and more sustainable Tamil Nadu.





#### 1. Introduction

Plastic is one of the most widely used packaging materials due to its lightweight, durable, and cost-effective nature. It is integral to sectors such as food and beverages, pharmaceuticals, personal care, e-commerce, and logistics. However, these very advantages also create challenges once plastic packaging is discarded. Large volumes of waste escape formal collection systems, accumulating in landfills, water bodies, and open environments, leading to persistent ecological and health risks.

To address these issues, the Ministry of Environment, Forest and Climate Change (MoEF&CC), Government of India, notified the Plastic Waste Management (PWM) Rules in 2016. The rules were subsequently strengthened with the introduction of Extended Producer Responsibility (EPR), a policy mechanism designed to improve the management of plastic packaging waste. Under this framework, Producers, Importers, and Brand Owners (PIBOs) are obligated to take responsibility for the environmentally sound collection, processing, and disposal of the plastic packaging they place on the market.

Recyclers play a pivotal role in this framework by converting collected plastic packaging waste into secondary raw materials, thereby reducing dependence on virgin plastic and promoting circularity. Their role ensures that plastic re-enters the production cycle rather than ending up as waste.

To promote transparency and accountability in implementation, the Central Pollution Control Board (CPCB) has developed a Centralized EPR Portal (<a href="https://eprplastic.cpcb.gov.in/#/plastic/home">https://eprplastic.cpcb.gov.in/#/plastic/home</a>). All obligated entities, including PIBOs and Plastic Waste Processors (PWPs), are required to register on this platform. The system authorizes only compliant facilities to participate in the recycling chain, thereby strengthening efficiency, credibility, and sustainability in plastic waste management across the country.

This section covers the list of EPR-registered plastic packaging waste recyclers, highlighting facilities authorized to process and recycle plastic packaging waste in an environmentally sound manner.


### 2. Zone wise details of Plastic Packaging Waste Recyclers in Tamil Nadu

#### 1. Introduction

E-Waste refers to electrical and electronic equipment (EEE) discarded as waste, including parts or rejects from manufacturing, refurbishment, and repair processes. With rapid technological advancement, the generation of such waste has become a significant environmental challenge. Responsible management of e-waste is essential to minimize environmental and health risks.

The Ministry of Environment, Forest and Climate Change (MoEF&CC), Government of India, notified the E-Waste (Management) Rules, 2022 in November 2022, which have been in force since 1st April 2023. These rules, along with subsequent amendments, establish the Extended Producer Responsibility (EPR) framework for environmentally sound management of e-waste. Under this framework, all manufacturers, producers, refurbishers, and recyclers are required to register on the Central Pollution Control Board (CPCB)'s online portal at <a href="https://eprewaste.cpcb.gov.in/">https://eprewaste.cpcb.gov.in/</a>.

As per the rules, a 'Recycler' is defined as any person or entity engaged in recycling and reprocessing of waste electrical and electronic equipment or assemblies, components, or parts to recover precious and semi-precious metals, rare earth elements, and other useful materials. Recyclers must operate facilities that comply with CPCB guidelines for environmental protection and occupational safety.

Schedule I of the E-Waste (Management) Rules, 2022, categorizes EEE into seven broader classifications encompassing 106 different types of equipment. In Tamil Nadu, e-waste recyclers employ a range of technologies and processing capacities to recover valuable materials and reduce the environmental impact of discarded e-waste. Their operations contribute to resource efficiency by converting e-waste into secondary raw materials, thereby supporting the circular economy.



#### 1. Introduction

Waste batteries include used, end of life battery and/or its components spares or parts or consumables which may or may not be hazardous in nature. It also includes pre-consumer off-spec battery, expired battery and battery discarded by the user. Battery waste poses significant environmental and health challenges due to the hazardous materials they contain. Improper disposal can lead to soil and water contamination, adversely affecting ecosystems and human health.

To address these challenges, the Ministry of Environment, Forest and Climate Change, Government of India, New Delhi, notified the Battery Waste Management Rules, 2022 on 22/08/2022, superseding the Batteries (Management and Handling) Rules, 2001, under the provisions of the Environment (Protection) Act, 1986. These rules apply to producers, dealers, consumers of batteries, as well as entities involved in the collection, segregation, transportation, refurbishment of used batteries, and recycling of waste batteries. They cover all types of batteries regardless of chemistry, shape, volume, weight, material composition, and use.

A key component of these rules is the Extended Producer Responsibility (EPR) framework. Producers, recyclers, and refurbishers defined under these rules are required to register on the EPR Portal at <a href="https://eprbattery.cpcb.gov.in/">https://eprbattery.cpcb.gov.in/</a>. As per the rules, a 'Recycler' is any entity engaged in recycling waste batteries.

Tamil Nadu's battery waste recyclers play a critical role in mitigating the environmental hazards posed by discarded batteries of various types, including automotive, electric vehicle, industrial, and portable batteries. With varying processing capacities, these recyclers significantly contribute to the recovery of valuable metals, thereby reducing dependency on virgin raw materials and curbing hazardous waste disposal.



### 1. Introduction

"Waste tyre" means any tyre, including tubes and flaps that are no longer mounted on a vehicle and are no longer used for its intended purpose. Waste tyres represent a significant environmental and public health challenge due to their non-biodegradable nature and the potential release of toxic substances when mismanaged. Improper disposal such as open dumping or burning can lead to soil and groundwater contamination, air pollution, etc.

Given the increasing volume of end-of-life tyres (ELTs) generated and its impact, the Ministry of Environment, Forest and Climate Change, Government of India, notified the Hazardous and Other Wastes (Management and Transboundary Movement) Rules, 2016, which include the management of waste tyres under Schedule VI. Further strengthening this regulatory framework, the Ministry introduced the Extended Producer Responsibility (EPR) Framework for Waste Tyres, wherein all producers, recyclers, and retreaders are required to register on a portal <a href="https://eprtyres.cpcb.gov.in/">https://eprtyres.cpcb.gov.in/</a> developed by the Central Pollution Control Board (CPCB). The EPR mandates environmentally sound management of ELTs through recycling, retreading, and energy recovery.

"Recycling" means any process or action of converting waste tyre into end products like reclaimed rubber, crumb rubber, recovered carbon black, and pyrolysis oil or char, in an environmentally sound manner and having facilities as elaborated in the standard operating procedure or guidelines as specified by the Central Pollution Control Board.

Tamil Nadu, being one of India's leading tyre manufacturing hubs, also fosters a robust and growing tyre recycling ecosystem. This growing tyre recycling ecosystem is actively supported by the Tamil Nadu Pollution Control Board (TNPCB) and operates in line with CPCB's environmental guidelines. Through integrated efforts in collection, segregation, and advanced processing, Tamil Nadu is steadily progressing toward a sustainable, resource-efficient, and legally compliant waste tyre management system.

This section covers the list of EPR-registered Waste tyre recyclers, highlighting facilities authorized to process and recycle plastic packaging waste in an environmentally sound manner.



#### 1. Introduction

"Used oil" means any oil derived from crude oil or mixtures containing synthetic oil including spent oil, used engine oil, gear oil, hydraulic oil, turbine oil, compressor oil, industrial gear oil, heat transfer oil, transformer oil and their tank bottom sludges; and suitable for reprocessing, if it meets the specification laid down in Part A of Schedule V of the Hazardous and Other Wastes (Management and Transboundary Movement) Rules, 2016, but does not include waste oil;

The generation of used oil has become a critical environmental concern in this era of increasing industrialization and consumption. The Ministry of Environment, Forest and Climate Change, Government of India, New Delhi has notified the Hazardous and Other Wastes (Management and Transboundary Movement) Rules, 2016 under the Environment (Protection) Act, 1986. These new rules and subsequent amendments intend to manage hazardous waste and put in place an improved Extended Producer Responsibility (EPR) regime for used oil recycling (Chapter VII) wherein all producers, recyclers, collection agents and used oil importers are required to register on a portal <a href="https://eprusedoil.cpcb.gov.in/">https://eprusedoil.cpcb.gov.in/</a> developed by Central Pollution Control Board (CPCB). As per the rules, recyclers are any person or entity engaged in the process of re-refining of used oil to produce base oil or lubrication oil or any process of energy recovery from used oil in an environmentally sound manner with facilities as elaborated in the standard operating procedure or guidelines issued by the Central Pollution Control Board for the purpose of Chapter VII of the Hazardous and Other Wastes (Management and Transboundary Movement) Rules, 2016, as amended.

Used oil recyclers in Tamil Nadu form a crucial part of the state's efforts to minimize environmental pollution and promote resource sustainability. By enabling the circular economy, these recyclers reduce dependence on virgin materials and lower the volume of hazardous waste.
