I submit to inform that the unit of M/s.Nalani Annamalayan Rough Stone and Gravel Quarry has proposed to carryout fresh quarry operation at SF.No.227/1, 227/2A, 227/3A & 228, Chinnakamanpatti Village, Sattur Taluk, Virudhunagar District. As the project attracts EIA Notification 2006, it was proposed to conduct Public Hearing at **S.M Thiruma Mahal, No.4/214B, Madurai By Pass Road, Near Sivakasi Piruvu , Sattur - 626 203, Virudhunagar District** on 15.04.2020 at 3.00 PM and the Notification in this regard was published in the New Indian Express and Dinamani dated :05.03.2020.

In this circumstances, it is submitted that the Government of India and the Government of TamilNadu have announced curfew till 14.04.2020 to avoid spreading of Corona Virus.
