**Subject: Selection to the Post of Member Secretary, Tamil Nadu Pollution Control Board – Reg.**

Applications are invited from eligible Indian Nationals for selection and appointment to the post of Member Secretary, Tamil Nadu Pollution Control Board (TNPCB) Chennai

1. The TNPCB was constituted under the Water (Prevention and Control of Pollution) Act, 1974 (Central Act 6 of 1974). The TNPCB exercises functions related to prevention and control of pollution. The Member Secretary shall be a full time incumbent.
2. The following are the terms and conditions for the post of Member Secretary, TNPCB, Chennai

1	Method of Appointment	The Member Secretary shall be appointed by the State Government.
2	Term of office	Three years from the date of appointment:  Provided that notwithstanding the expiration of the term, a person appointed as Member Secretary shall continue to hold office until his successor enters upon his office.
3	Qualification and Experience	(i) Must possess a post graduate degree in Engineering or Technology in Environmental Engineering or allied Sciences. (ii) 25 years field experience in Environmental Protection and Enforcement of Environmental legislation.
4	Pay	The Member Secretary of the Board shall be paid a salary in the Level 31 Minimum 125200 – Maximum 219800.
5	Age Limit	Must not have completed 60 years ( As on the closing date of application)

**Note 2:-**The candidates working in the Central or State government or Public Sector Undertaking or Universities or Government research Institutions or Autonomous or Statutory bodies may send their applications in four (4) sets through **proper channel** along with attested copies of up-to-date Annual Confidential Report (ACR), Integrity Certificate, details of minor / major penalties imposed, if any, and Vigilance clearance. In case of such officers, the parent Ministry / Department / Organization before forwarding the applications should strictly ensure that the applicant officer fulfils the eligibility criteria stipulated for the post as explained above. Advance copy of the application may be sent, but before the interview the official clearance needs to be obtained.

**Note 3:** The applications **not received through proper channel within the due date** are liable to be rejected.

**Note 4:** The Selection Committee may conduct interview for the shortlisted candidates and the decision of the Selection Committee will be final. All disputes are subjected to the jurisdiction of court in Chennai city only.
